## Responsibilities

I work on staff at the State of California Regional Water Quality Control Board performing a broad range of activities related to protecting beneficial uses of water resources, including coordination of surface water programs with other regulatory and public agencies, and with the public in general. Currently, my duties include grant management work overseeing technical and administrative aspects of a variety of grants to public agencies and non-profits for projects enhancing water quality in the San Francisco Bay Region. I am the Regional Board's representative to State-wide programs such as Critical Coastal Areas and Agricultural Waiver of Waste Discharge Requirements for irrigated agricultural lands. I also coordinate the upcoming grazing lands permit for watersheds under Total Maximum Daily Load allocations, and perform some work related to confined animal and horse boarding facilities programs.

I have worked in the Industrial and Construction Stormwater Permit programs, and the Phase II Municipal Stormwater Permit process. I have developed and made presentations to the Board concerning Waste Discharge Requirements for the Devil's Slide Tunnel Project, and enforcement actions.
