Why I want to be appointed to the City Council:

I have attended many meetings of the city council and understand the scope of the job and the importance of community visibility and accountability; I have served on the San Leandro school board and other responsible positions that required hours of commitment and time away from my work; I would consider the City Council position as my part-time job and give it as much time as required. I feel that my broad range of experience in both elected and appointed positions would give the council a dimension that it needs. I understand difficult concepts and understand how to read a budget and determine the urgent categories and priorities; I am used to working with diverse groups of people with various points of view and generally am successful in representing the needs and desires of community members, as necessary, instead of only my point of view.

Education, training, and/or special certifications; previous boards, commissions:

PTA -- joined in April 1977; became officer in September 1977 and have served every year since then as an officer or chairman (30 years) -- was District President for Alameda County from 1993-1995 and served on the state board of managers during that time; currently serving as District Membership Chairman

Served on San Leandro School Committees: Human Sexuality Committee -- helped develop a continuous 12-year sex education curriculum; Instructional Advisory Committee that later became Board District Advisory Committee from 1986 to 1992 -- helped developed the tenth grade curriculum that assists teens to learn how to apply for jobs and other pertinent community programs; served on the steering committee of Save Our Schools from 1982 to 1985 -- encouraged the school district to equalize trustee area representation; attended annual curriculum conferences on learning disabilities and learning styles and brought back information to the board and staff

Elected to the San Leandro Board of Education in 1992 and served through 2000; ran for the board in 1984, 1988, and was elected in 1992 and 1996; chose not to run to concentrate more on my business, Holcomb's Home Repair; attended all the Conferences statewide that the school district would allow, paying for several for myself

Served on the City of San Leandro Human Resources Commission from 1986 to 1988 --

this changed names to the Human Services Commission; served on the Recreation and Parks Commission from 1988 to 1992 when I was elected to the school board -- resigned to avoid conflict of interest; appointed to Planning Commission in 2001 and am currently serving in that position.

I am a licensed general contractor who has been continuously working in the field for 29 years -- first, part-time while my children were still in school, and full-time since 1988.

I am active in the community, even though I have no homeowner's association -- I attend many school board meetings, city council meetings, and community meetings: for the ten years that I ran for the local school board I missed only three meetings of the city council or school board. I recently ran for the County Board of Education and did not succeed. I frequently help in many election campaigns -- both persons and issues. For the last three years, I have been the sole support of myself and household and have not been as involved as previously. I recently married again and am enjoying companionship at home and work.

My education included attendance at University of California, Berkeley and University of California, San Francisco. I studied sciences in order to become a nurse and left the training to get married in 1966. I have two children, both in their thirties -- they were educated in the public schools in San Leandro.

In addition to the activities that I previously listed, I also served as Chair of the Committee on Homeless when on the Human Resources Commission; I wrote and published newsletters for PTA at the high school; I also served on the Disaster Preparedness Committee; and, served on the Cherry Festival Committee the years that it was being established (1986 -- 1989).
